

Junckers Ltd require notification of the confirmed delivery date, full site address, contact person, mobile phone number and offloading requirements.

VEHICLE LOADING:

Flooring products will be stacked up to 3 pallets high.

For deliveries where you require the pallets of flooring to be stacked 2 pallets high, please contact customer service for a delivery price.

DISPATCH LEAD-TIME:

- A&B Items: 10 working days (maximum order of 250m²)
- C Items: 20 working days (251m² 600m²)
- D items are subject to stock availability.
 We recommend you confirm dispatch lead-time at the time of order placement

DELIVERY SERVICE:

Our standard delivery service is to UK mainland only between 08.00am and 16.00pm, Monday to Friday (excluding Bank Holidays). We expect the majority of the deliveries between 08.00am and 12.00pm.

DELIVERY CHARGES:

- Articulated lorry: £160 per delivery
- Rigid non articulated lorry: From £490 per delivery
- Courier: £80 per delivery (restrictions apply)
- Proforma Customers £490 delivery charge applies per standard delivery

TIMED DELIVERY CHARGES:

We can also offer a fixed delivery time with a 2-hour time slot. E.g. between 08.00am and 10.00am. The charge for this will be:

- Articulated lorry: £330 per delivery
- Rigid non articulated lorry: £660 per delivery

MOFFETT SERVICE:

We offer Moffett unloading of goods: £970 When placing your order for Moffett deliveries please be aware that we will need 3 to 4 days extra for the shipment in order for us to book the Moffett lorry.

FORS SILVER SERVICE:

We offer lorries equipped to FORS Silver standard: £680

When placing your order for FORS Silver deliveries please be aware that we will need 3 to 4 days extra for the shipment in order for us to book the FORS Silver lorry.

EXPRESS DELIVERY CHARGES:

We offer an express delivery service where goods are required in less than the dispatch lead-times shown above.

IMPORT DOCUMENTS:

We charge £120 per delivery for import documents required to deliver goods to UK locations.

ROAD TRANSPORT TAX:

From 1st January 2025 we charge £40 per delivery for Danish Road Transport Tax.

OFFLOADING OF GOODS:

Customers are responsible for making available appropriate mechanical handling equipment, or site labour for offloading goods from delivery lorry.

We allow 1 hour for offloading free of charge, subsequent time will be charged at £130 per hour or part of.

PLEASE NOTE: Junckers delivery drivers are only contracted to deliver and not unload, any assistance they may offer is at their own discretion. We recommend a minimum of 3 people to be sent to site when unloading by hand.

STORAGE OF GOODS:

- Should changes occur after Junckers have dispatched goods the options are:
- To arrange delivery to an alternative address
- Junckers hold goods in storage for a maximum of 7 days. A storage charge of £70 per day will be levied from the day of original planned delivery date.
- If the goods are held in storage Junckers require 72 hrs notice of the new delivery date.

PEFC™ AND FSC® PRODUCTS:

As standard PEFC[™] and FSC® products are supplied. For chain of custody information please refer to our Order Confirmation. Kindly contact customer service if PEFC[™] and FSC® goods are not required.

CUSTOMER CHANGES TO DELIVERY DATE:

Should a delay to customer requested delivery date be requested within 14 days of the agreed shipment date, Junckers reserve the right to finalise production and invoice the order according to the originally agreed shipment date and charge a warehouse rent of 2% per commenced month until the order has been shipped. Any cost associated with delivery delays after shipment motivated by the customer will be the customers responsibility.

All times and dates for dispatches and deliveries quoted are estimates and not binding on the company. Times given are on best endeavours basis and are subject to force majeure.

The Company will sell and the Customer will purchase the supplies in accordance with any written order of the Customer which is accepted by the Company subject to these conditions which will govern the contract to the exclusion of any other terms and conditions.

- 1.2 No variation to these conditions will be binding unless agreed in writing.
- 1.3. Any recommendations given by the Company or its employees or agents to the Customer or its employees or agents as to the storage, applications, suitability or use of the supplies (including quantities) which is not confirmed in writing by the Company is followed entirely at the Customers own risk, and the Company will not be liable for any such recommendation which is not so confirmed.
- 1.4 Any typographical, clerical or other error or omission in any literature, document or information issued by the Company will be correctable without any liability on the part of the Company.

ORDERS AND SPECIFICATIONS

Subject to the Conditions the quantity, quality and description of and any specification for the goods will be those set out in the Company's quotation or Order Acknowledgment or as otherwise agreed or accepted by the Company in writing.

All dimensions quoted are nominal only and standard sizes may be changed by the Company without notice. Supplies are provided subject to the grading rules applicable in the country of manufacture.

CUSTOMER RETURNS

The Customer is legally bound to purchase the Supplies comprised in the Contract and no return will be accepted without the Company's prior consent in writing.

DAMAGED GOODS

The customer must notify Junckers in writing:

All visible damage must be marked clearly on the Dispatch note/CMR upon receipt of the goods and sent to Junckers immediately, including a copy of the CMR, stating Junckers invoice number and order number.

Junckers must be informed of any unseen damage within 3 calendar days of the date of receipt of the goods, stating Junckers invoice number and order number.

Advice in writing will be sent from Junckers to the customer to inform whether to destroy or return the goods. If the goods are being returned, a Return Authorisation number will be issued and collection arrangements will be made in conjunction with the customer. Should Junckers attempt collection and for any reasons are unable to collect the goods from the customer's premises, the customer will be liable for any charges.

Goods dispatched in error by Junckers or incorrectly delivered goods by Junckers. Any goods received by the customer which have not been ordered, or any shortages in delivery or any incorrectly delivered goods should be reported to Junckers within 3 working days of receipt of goods.

The dispatch note must be marked "goods dispatched in error" or "shortage in delivery" or "incorrect delivery" against the item when being signed for.

Advice in writing will be sent by Junckers to the customer to inform whether to destroy or return the goods. The goods must be kept in a dry place until collected and in a saleable condition.

If the goods are to be returned, a returns advice note will be raised and collection arrangements will be made in conjunction with the customer. After the collection date has been agreed, if for any reason the goods are not on site, or not found for return, the customer will be liable for any carriage charges and cost of the materials.

Any products from the Design Collection or products with special features which have been specially made cannot be returned. We will accept a cancellation without charge on these special products up to 2 weeks prior to dispatch.

OPTION 1

The customer or their own carrier service can arrange for any goods over- ordered or incorrectly ordered to be returned to our factory.

All returns are to be made by the customers own transport.

These goods will only be accepted if prior notification in writing has been confirmed by Junckers stating invoice number.

The goods must have been kept in a dry place and be in a saleable condition on arrival at Junckers premises.

All hauliers must, when returning goods, report to the warehouse office for authorisation and unloading. The goods must have been purchased and subsequently invoiced within the last 3 months. A 30% handling charge is applicable.

OPTION 2

Junckers will arrange for any goods overordered or incorrectly ordered to be returned. These goods will only be accepted if prior notification in writing has been confirmed with Junckers stating invoice number. The goods must have been kept in a dry place and be in a saleable condition on arrival at Junckers premises. The goods must have been purchased and subsequently invoiced within the last 3 months. A 30% handling charge is applicable plus the costs involved in collecting the goods and returning them to our factory.

This will be agreed on each and every case before the goods are collected by Junckers Ltd.

The Company will not in any event be liable for loss of profit, injury, damage or any consequential or specific loss or damage sustained by the Customer how so ever arising and in no event will the Company's liability exceed the invoiced price of the goods.

RISK

The Customer will insure the Supplies against loss or damage in their full invoice price in the joint names of the Company and the Customer from Delivery until payment in full has been made.

DELIVERIES

Refer to page 5 for delivery details and costs. When carriage is arranged by the Company, delivery will be deemed to take place at the moment when possession or control of the Supplies is offered or transferred to the Customer or its agent at a delivery Address before offloading or otherwise. When carriage is arranged by the Customer, the delivery will be deemed to take place when possession or control of the Supplies is passed by the Company to the carrier.
